Where can I travel in Europe?

Everything you need to know about the requirements to travel in Europe.

Albania:

Opened to **ALL** nationalities without any tests or other covid-related requirements whatsoever.

Austria:

For tourism puposes Austria is opened to European citizens and **SOME** others (e.g. USA, Canada, Japan, Singapore, South Korea, Hong Kong, Taiwan, Vietnam, Israel, etc).

Belgium

Belgium is open for **MOST** countries except those considered a Very High Risk. They accept EU covid certificates or equivalent. Travelers arriving from "green" or "orange" zones are not subject to testing or quarantine requirements, those arriving from "red" countries need to take another test on day 1 or 2 after arrival.

Bosnia and Herzegovina:

EVERYBODY can enter Bosnia and Herzegovina with one of the following: a proof of vaccination, recovery or a test.

Bulgaria:

Bulgaria can be visited by **MOST** countries. Only those coming from a "red" country are not allowed to enter. All you need is **certificate of completed vaccination** against COVID-19 or a document showing a positive result of a PCR or rapid antigen test for persons who have **recovered from COVID-19 between 11 and 180 days** or a document showing a negative result of a COVID-19 test (PCR test carried out within 72 hours before entering the country, or a rapid antigenic test carried out within 48 hours before entering the country).

Croatia:

Opened to **ALL** nationalities with proof of full vaccination completed at least 14 days before, proof of recovery in the last 6 months or PCR test.

Cyprus:

EVERYBODY can enter Cyprus. The country is following a color-coded system harmonized with evaluation standards set by the European Centre for Disease Prevention and Control (ECDC). Travelers arriving from countries classified as "GREEN" can enter Cyprus without a test. Travelers arriving from countries NOT classified as "GREEN" can enter Cyprus without a test or having to isolate in case they have been **fully vaccinated**. All other travelers arriving from countries classified as "ORANGE" or "RED" are subject to the requirement for a **pre-departure negative PCR test**. The test must be taken within **72 hours prior to the flight departure**. Additionally, travelers from countries classified as "RED" are subject to a **second test upon their arrival**, at their own expense.

Czech Republic:

Travelling is allowed from **SOME** countries, who are in low or medium risk category. This includes most of European countries as well as Hong Kong, Taiwan, Singapore, South Korea, Japan, Israel, Canada, USA, Qatar, Saudi Arabia, Jordan and some others. Travelers have to have a negative PCR test, a vaccination or recovery proof. Travelling from all other countries, which are classified as high risk or very high risk, is allowed only with an obligatory self-isolation.

Denmark:

Denmark is opened to **MOST** countries. Danish travel restrictions classify all countries and regions around the world into four categories: green, yellow, orange and red. These color categories determine which rules apply to you on your arrival in Denmark. Vaccinated travelers from Green, Yellow and Orange countries can freely enter Denmark without any further proof or requirements needed. Only travelers from red listed countries require tests and self-isolation. Currently these include: South Africa, Russia, Argentina, Colombia and few other countries.

Estonia:

EVERYBODY can enter Estonia as long as they are fully vaccinated. Those coming from Green countries as designated by the EU don't need any other tests, others do need a negative test.

Finland:

Travelling to Finland is allowed for **EVERYBODY** who has been vaccinated (Astra Zeneca, Pfizer, Moderna, Johnson&Johnson and also Covishield, Sinopharm and Sinovac vaccines are acknowledged). At least 14 days have to pass from the final dosage. Apart from that residents of EU and Schengen countries and also those of Albania, Australia, Bosnia and Herzegovina, Hong Kong, Brunei, Canada, Kosovo, Macau, New Zealand, North Macedonia, Taiwan and Ukraine, are also allowed to travel without vaccination proof.

France:

Has opened their doors for **MOST** travellers! As long as they are fully vaccinated. For the EU and a number of other countries, vaccination is enough. However for some countries vaccination + PCR test is required. Non vaccinated travellers are not allowed to enter as tourists. Also Latin America, South Africa, India, South Asia and Russia are currently still not allowed to enter.

Germany:

Travelling to Germany is allowed for **EVERYBODY**. Travellers aged 12 or over must as a rule carry with them a negative test result, proof of vaccination or proof of recovery when entering the country. In the context of policing cross-border traffic into Germany, such proof may also be demanded by the Federal Police or other responsible authority. Persons travelling by air must already present such proof to their carrier before departure. Travellers entering the country following a stay in a high-risk country must present a negative test result to the airline before departure (proof of vaccination or recovery isn't sufficient) (such proof may also be required by police on other cross-border traffic controls). Such test must not be older than 48 hours (for antigen tests) or 72 hours (for PCR tests). When entering from an area with variants of concern, this time frame is reduced to 24 hours for antigen tests.

Greece:

MANY of the countries are allowed to enter Greece – with vaccination proof, having gone through covid already or with PCR or rapid antigen tests. Countries include all of the EU as well as USA, UK, Canada, China, Israel, South Korea, Singapore, Japan, Russia, UAE and others.

Hungary:

Is opened to **SOME** countries. These include all European countries who hold a covid certificate scheme and also few other countries, from which Hungary accepts documentation proofs (such as USA, Canada, Bahrain, Turkey and few others).

Iceland:

EVERYBODY can travel to Iceland without the need for self-isolation as long as they are fully vaccinated. All approved vaccinations are acknowledged (Pfizer, Moderna, Astra Zeneca, Johnson&Johnson, Covishield, Sinopharm, Sinovac).

Ireland:

Travelling to Ireland is allowed from **MOST** of the world. Either EU Covid passport or alternative proof showing Proof of Vaccination (Pfizer, Moderna, Astra Zeneca and Johnson&Johnson are acknowledged), Proof of Recovery within 180 days or a PCR tests within the last 72 hours. If you are however travelling from one of the “designated states” an obligatory self-quarantine is required (minimum 5 days). Italy:

Travelling to Italy is allowed from **SOME** countries. Currently it is possible to enter to all EU citizens with EU covid certificates (with completed vaccination at least 14 days before, a negative molecular or antigen test not older then 48 hours or certificate of recovery not older then 6 months). Same proofs are accepted for travelers from the USA, Canada and Japan. Travelling to Italy from the rest of the world for tourism is not permitted. However transit is allowed and also certain other exemptions exist.

Latvia:

Vaccinated travelers can travel without any tests to Latvia from **MOST** of the world. Except if they are coming from a country where the 14-day cumulative number of Covid-19 cases per 100.000 population exceeds 75. In this case a 10-day self-isolation must be observed (which can be shortened if the test is repeated on day 7 and is negative).

Lithuania:

EVERYBODY can travel to Lithuania. Those living in extremely affected countries can avoid self-isolation if they are fully vaccinated or have a proof of recovery. Here are details on countries classifications and exact regulations:

Luxembourg:

Visiting Luxembourg is allowed for **SOME** countries. Apart from all EU countries this includes also Canada, USA, Japan, Taiwan, Israel, South Korea, Ukraine and few others. Everybody needs to present either a vaccination proof, a proof of recovery or a negative PCR test.

Montenegro:

Is opened to **ALL**, only rapid test, PCR test or antibody test are required to enter.

Netherlands:

The country is opened for **SOME** countries. If you are travelling from the EU or certain other "safe" countries (Canada, USA, Japan, Taiwan, Israel, South Korea, etc) you only need to have vaccination proof or a negative test result. If you are travelling from all other countries, self-isolation is mandatory.

Norway:

Norway can be visited from **SOME** countries. Foreigners who are residents of a country or area classified as "green" from an epidemiological point of view; and foreign citizens holding an EU Digital COVID certificate (EUDCC) that is valid in Norway and that shows that you are fully vaccinated or have had COVID-19 during the preceding six months. This also includes residents from England and Wales, but not yet Scotland and Northern Ireland. All others need self-isolation or they can not enter Norway at the moment with some exceptions.

Poland:

Poland is opened to travelers from EU and Schengen countries, as well as Turkey. Tourists from those places can arrive in Poland with vaccination proof, proof of recovery or a negative test. All others have to show a vaccination proof (only EU approved vaccines are acknowledged, so Pfizer, Astra Zeneca, Moderna and Johnson&Johnson) or a proof of recovery. Otherwise they need to undergo an obligatory 10 days self-isolation.

Portugal:

Travelers are allowed from the EU, Schengen countries and also Australia, Canada, China, South Korea, USA, Israel, Japan, New Zealand, Saudi Arabia, Singapore, Taiwan, Ukraine and few others. Either a valid EU Covid passport is required or a PCR or antigen tests. Travelers from Brazil, India, Nepal and South Africa need to undergo an obligatory self-quarantine.

Romania:

MOST of the countries can travel to Romania without any specific requirements. Only several countries have to show PCR tests (e.g. Malaysia and UAE). Only red list countries need to undergo obligatory self-isolation (these include UK, most of Latin American countries, South Africa, India and few others).

Serbia:

Opened to **ALL** nationalities, only a PCR test is required.

Slovakia:

EVERYBODY can travel to the country as long as they are fully vaccinated (they also don't need to undergo any further testing). Unvaccinated travelers need to go to obligatory self-isolation upon arrival, unless they fulfill certain exemptions criteria.

Slovenia:

Is opened to **ALL** nationalities, proof of vaccination or certificate of recovery from covid are needed for travellers from certain countries to avoid self-isolation.

Spain:

Opened to **ALL** nationalities as long as they can prove they have been vaccinated children above 12 need to be able to demonstrate that, too).

Sweden:

EVERYBODY can enter Sweden now. EU and Schengen area residents need to show Covid passports (certificates) and non EU residents need to show either proof of full vaccination (Pfizer, Moderna, Astra Zeneca, Johnson&Johnson, Covishield, Sinopharm, Sinovac) OR a test. Tests can not be older than 48 hours and can be any of the following: PCR, LAMP, TMA or antigen test.

Switzerland:

ALL travellers who have been fully vaccinated can enter Switzerland.

UK:

As the last European country to open up the UK has finally started to invite travelers from foreign countries. Everybody coming from green or amber countries can travel to the UK, only red countries still can't. Unfortunately only European and vaccination program of USA are currently being recognized. Green listed countries need a test before arrival and on Day 1 or 2 upon arrival. Amber listed countries need to show vaccination proof while still doing the same tests, however those unable to proof vaccination from a European or American vaccination program, have to self-isolate for 10 days.
